This is with reference to a meeting of AAC held online on July 24, 2020. The following members were present:

Agenda: Requirement and advertisement of faculty positions on contractual positions.

Discussion: It was discussed that there are only four faculty members in the department running three programs, which include M. Pharm. (Pharmaceutical Chemistry), M. Pharm. (Pharmacognosy) and M.Sc. (Medicinal Chemistry), while other three posts are lying vacant due to retirement and resignations of three faculty members. The department is duly approved by Pharmacy Council of India (PCI) as well as All India Council for Technical Education (AICTE) till date. Due to this severe faculty deficiency, **we are deficient and will soon lose approval from both AICTE as well as PCI.** Further, departmental teaching will suffer badly due to the high workload situation created due to these vacant posts. Therefore, in order to remain compliant with PCI and AICTE as well as smooth running of upcoming academic sessions, there is an urgent requirement of minimum four positions of faculty members.

Resolution: Considering the above facts, and in order to meet the urgent need, committee unanimously resolved that, at least two positions of Assistant Professors on contractual positions with the following specialisations may be advertised:

2	Assistant Professor (Contractual)	Ph.D. with specialisation in Pharamcognosy/Phytochemistry/Natural Products with a basic degree in Pharmacy, registered pharmacist and qualification as per Pharmacy Council of India (PCI)/UGC guidelines. GPAT/GATE qualified in Pharmaceutical Sciences/Pharmacy stream
