Minutes of 50thAcademic and Administrative Committee (AAC) Meeting

50th Academic and Administrative Committee (AAC) meeting was held on 10th of January 2020at 12:15 P.M. in Department of Sociology. The following issues were discussed and following were the resolutions taken:

- 1) The time-table for the next semester (Jan-June, 2019) was discussed, along with course allotment and was finalised.
- 2) It was decided that, students from M.A. 4th semester will have to present their work in progress report once in a month for the course: Project Work II. This presentation will be mandatory for the students.
- 3) Course on Rural and Agrarian Societies (SOC.524) will be shared between Dr. Aditya R. Kapoor (for Unit I and II) and Dr. Sumedha Dutta (for Unit III and IV).
- 4) Dr. Sumedha Dutta will be MOOC coordinator for the MOOC courses taken by the students of the Department for the ongoing semester.
- 5) It was decided that regarding course SOC.575 Practice Exercise I, students will be engaged with practice exercises based on application of theories and concepts. And in the course, SOC.576 Practice Exercise II, students will be engaged with assignments pertaining to research aptitude.
