- 6. Regarding the recognition of Chartered Accountancy qualification for admission/registration to Ph.D. Programme in Commerce in the Department of Financial Administration, it was resolved to fix the eligibility criteria as "A qualified Chartered Accountant having secured 60% marks in aggregate or equivalent, along with graduation in Commerce and with professional experience of Five Years'.
