It was proposed to shift fundamental duty to the last unit.




After deliberations on the above, the proposed contents were approved with reshuffling as suggested by the External Members.


The Course codes were revised as per the recommendations of IQAC and placed before the Board of Studies. The proposed contents of following courses were examined by the Members.

The meeting ended with a vote of thanks to the Chair.






