1. Agenda: Syllabus of MA (Journalism and Mass Communication) for session 2019-2021.

Resolution: It was discussed and recommended

2. Agenda: To discuss observations made in syllabus of 3rd and 4th semesters of MA (Journalism and Mass Communication) Batch 2018-20 by Curriculum Development Committee. The observations are as follows:-

- The total credits of last scheme were wrongly calculated as 98 whereas correct total was 92. It was also found that the total credits of 3rd semester was wrongly calculated as 22 whereas correct calculation was 25. Similarly, in the 4th semester total credits were wrongly calculated as 19 whereas correct calculation was 22.

- It was also noted that course codes and credits of some courses in the syllabus were wrongly written though they were correct in the scheme, hence, corrections were made accordingly in making the proposed scheme and syllabus consistent.
- Two papers of Discipline Enhancement Courses of 2 credits each in fourth semester as is made mandatory by IQAC. Hence, these are proposed to be included in the Curriculum.

Resolution: These were discussed and recommended with change in nomenclature of Discipline Enhancement Courses to Comprehensive View of Mass Communication –I and Comprehensive View of Mass Communication –II in 3rd and 4th semesters respectively.

Resolution: This was discussed and recommended without any changes.

Other resolutions:- Field trips/academia-industry interaction were strongly recommended for exposure of students to different field of media during the programme.


It was resolved to put the resolutions before the School Board.


Members also resolved to give power to chairperson to make need-based changes in the syllabus.




