Proceedings of the first meeting of the Building Advisory Committee

A Building Advisory Committee consisting of the following members constituted to advise the University for matters related to construction met in the office of the Vice Chancellor on 05.01.2010 to deliberate over the designs of Boundary wall for land of the university at VPO Ghudda:

The representatives of the following government organizations, shortlisted by the University, were called to give presentation on the designs of Boundary Walls:

1. CPWD – Represented by Mr. Rajinder Kumar, Assistant Engineer
2. RITES – Represented by Mr. Rajeev Nanda, J.G.M. (Civil)
3. EPIL– Represented by Mr. S.K. Jain, General Manager

The Committee studied the site plan of the university land available at village Ghudda. It deliberated on the agency's strength and the designs of the boundary wall as per presentations of these organizations. It held extensive discussions with their representatives. The Committee considered the various aspects including the strengths and weaknesses of the organizations and unanimously recommends that the EPI and RITES be provided with a standard uniform pattern of the wall and these be asked to submit detailed project report and costs for the Boundary Wall for university, after studying the topography etc., of the University land before final decision could be taken.



The basic parameters for the boundary wall were jointly prepared by the Expert Members in the shape of enclosed plan which were deliberated upon by all the members. The committee unanimously approved and decided that the plan be handed over to EPI and RITES for preparing the cost estimates.

Further, the committee recommended that in order to check haphazard and unplanned growth around the university, the State Government be approached:

- a) For declaring the Bathinda-Badal road a Scheduled Road under the Punjab Regional & Town Planning and Development Act, 1995 .
- b) The area around the university land should be declared as the Planning Area.




