Agenda Item 01: To review the credits and contents in view of NEP

The Chairperson introduced the members with the vision of the Department to implement National Education Policy (NEP) and shared that in view of the mandate of NEP, the curriculum has been redesigned to focus more on experiential learning, skill based course such as legal aid clinic, legal entrepreneurship, providing elective choices and promote critical thinking through research based exercises.

Agenda Item 02: To revise the credit allocation as per instructions of IQAC

Previously there were more than 90 credits and more emphasis was on clarity of fundamental concepts. However, as per the recommendations of IQAC and credit template approved by the Academic Council in its 24th meeting, the department has reshaped and re-allotted credits to different course i.e. Total 83 Credit as under:

1 st Semester	22 Credits
2 nd Semester	22 Credits
3 rd Semester	19 Credits
4 th Semester	20 Credits

Agenda Item 03: To examine and approve reflections in all courses and the course content of Discipline Specific, Discipline Enrichment and Inter-disciplinary Courses.

The Chairperson presented the course contents along with the reflections indicating the realization of learning outcome after completion of discussion on each Unit. The reflections drafted by the respective course coordinators were presented before the Committee and approved with minor suggestions.

The proposed course structure, course contents and re-allocation of the credits such as adding one credit to Value Added Course and reducing the numbers of Value Added Course from two to one; new IDC Course on Civil Defense were placed before the Committee for consideration and approved.


