Agenda 1:- Including Inter-Disciplinary Course titled 'JMC.530 Communication Skills' worth 2 credits in curriculum of MA (Journalism and Mass Communication ) from session 2020-21

Resolution: Inter-Disciplinary Course titled 'Communication Skills' worth 2 credits in curriculum of MA (Journalism and Mass Communication ) was included with minor changes in syllabus proposed.

Agenda 2 :- Including subject titled 'Research and Publication Ethics' in pre-PhD course work as directed by authority vide UGC letter, the paper has replaced 'JMC704 Applied Communication Research' and other changes (rephrasing of learning outcomes) done in the syllabus

Resolution: Subject titled 'Research and Publication Ethics' and other changes were also included in pre-PhD course work.

#### Minutes of CDC

The I<sup>st</sup> meeting of Curriculum Development Committee of the department was held on 20 February in office of the department at 11 a.m. The minutes of the meeting are as follows:-

Agenda 1:- Including two papers of Discipline Enhancement Courses of 2 credits each in fourth semester as is made mandatory by IQAC

**Resolution:** Two papers of Discipline Enhancement Courses of 2 credits each in fourth semester as is made mandatory by IQAC were included.

Agenda 2: Reducing the total credits of MA programme as after addition of 4 credits, it will go upto 102 credits

**Resolution:-** Before making any changes, it was found that the total credits of last scheme were wrongly calculated as 98 whereas correct total was 92. It was also found that the total credits of 3<sup>rd</sup> semester was wrongly calculated as 22 whereas correct calculation was 25. Similarly, in the 4<sup>th</sup> semester total credits were wrongly calculated as 19 whereas correct calculation was 22. These corrections were made in the meeting.

It was also noted that course codes and credits of some credits in the syllabus were wrongly written though they were correct in the scheme, hence, corrections were made accordingly in making the scheme and syllabus consistent.

Agenda 3:- To discuss syllabus of Inter-disciplinary Course 'Combating Fake News' proposed by Dr Rubal Kanozia

**Resolution:-** Syllabus of new Inter-disciplinary Course JMC515 'Combating Fake News', proposed by Dr Rubal Kanozia was proposed to be put before BoS.
