Agenda 1: To review and recommend the syllabus of M. Pharmacology and Ph.D. programs.

Resolution: The committee reviewed and recommended the syllabi for putting it in the forthcoming Board of Studies meeting for further recommendations and approval.

Agenda 2: Regarding inclusion of MOOC course in M. Pharmacology.

Resolution: The committee recommended that students may opt for two Inter Disciplinary Courses of 02 credits each or one MOOC course of 04 credits in first two semesters in M. Pharm(In principle approved by Competent Authority).

Further, the faculty of the Department will offer an Inter disciplinary Course of 02 credits and the syllabus for same were prepared and put in next Board of studies for recommendation and approval. Agenda 4: Regarding inclusion of Value Added Course(VAC) in M. Pharm.

Resolution: The committee recommended inclusion of one Value Added Course in M. Pharm. IIIrd and IVth Semester each (01 Credit each) in practical mode (02 hours/week; 01 Credit each) as per University guidelines for Value Added Courses (Notification no. CUPB/CC/COE/19/471) dated 31/07/2019 and letter no.CUPB/CC/20/2157 dated 29-01-2020.

Agenda 5: Regarding inclusion of a course on "Research and Publication Ethics"in pre-Ph.D. registration course work Resolution: The committee recommended the inclusion of a course on "Research and Publication Ethics" (30 hours) in pre-Ph D. registration course work from session 2020-21 as per directions of UGC. The course contains two sections i.e. Theory al\_ractice of 15 hours each. Since Theory portion deals with general aspects of Philosophy and Ethics, Scientific Conduct and Publication Ethics which are common to students of all Science disciplines, hence may be taught jointly at University level. However, Practice section is discipline specific and should be taught at respective Department level.
