Subject: Minutes of the Academic & Administration Committee (AAC) meeting held on 07.05.2021.

The Academic & Administration Committee (AAC) meeting was held on 7th May, 2021 at 10.30 am using google meet/online mode (https://meet.google.com/rdv-eikz-rwu). All the faculty members of the department attended the meeting. Dr. Puneeta Pandey and Dr. Ajay Kumar were directed to prepare the minutes of the meeting by the Chairman, AAC.

The agenda and resolutions of the AAC meeting are as follows.:

Agenda 1: Distribution of University funds Rs. 5,00,000 for consumables.

Resolution: The total University fund of Rs. 5,00,000 was equally distributed among all the faculty members, and some amount was allocated to the common teaching laboratory and departmental activities.

- i) Rs. 60000 to each faculty (60000 x 7 = Rs. 420000).
- ii) Rs. 60000 to common teaching laboratory
- iii) Rs. 20000 to Departmental activities i.e. Ph.D. Viva-voce, Invited Lectures etc.

Agenda 2: Transfer of equipment and chemicals to the common teaching laboratory.

Resolution: All faculty agreed unanimously to transfer the equipments and extra chemicals from their individual research laboratories to the common laboratory for common use.

Agenda 3: Syllabus and curriculum design as per the latest university guidelines.

Resolution: The latest syllabus format, evaluation pattern for theory, practical, DEC, Entrepreneurship, and project was discussed and it was decided to complete the same by 09.05.2021. Dr.Dhanya M.S. and Dr. Puneeta Pandey were directed to add activities to each unit of the syllabus.

Agenda 4: Progress of Syllabus of M.Sc. 4th Sem.

Resolution: The syllabus completion progress of M.Sc. 4th Sem was discussed and the committee was satisfied with the progress.

Agenda 5: Ph.D. candidates' distribution among faculty.

Resolution: The rules for Ph.D. candidates' distribution among faculty were discussed. All the faculty agreed unanimously and approved the following rules for Ph.D. supervisor allocation:

- i) Each faculty will provide their number of vacant seats or the seats offered for the Ph.D. admission for each session of admission.
- ii) At the time of the interview, the students will be informed about the available supervisors so that they can go through research areas.

- iii) After admission, each student has to give his/her choice in the order of preference 1, 2, 3..... of the available supervisors.
- iv) The criteria of allocation of the supervisor will be based on their merit in the admission.
- v) If merit in the admission is the same and 2 or more students have given preference for the same supervisor, then the choice of the supervisor will prevail.
- vi) The faculty who has not offered Ph.D. seats in a particular session may not be normally considered for allotment. However, in exceptional circumstances, if a supervisor is agreed to leave his seat, and the other one is ready to offer a seat, then this may be considered.
- vii)In case of less number of admission than the offered seats, efforts should be made to give at least one student to faculty who do not have any Ph.D. student.

The meeting ended with a Vote of Thanks by HoD to all the faculty members.
