The members of the committee discussed needs of Students with Disabilities as well as for implementation of the schemes and the members unanimously recommended as follows:


- 1. Dr. Shankar Lal Bika, Associate Professor, Department of Education to be Co-opted in the Committee as an Expert in Special Education.
2. Dr. Bika and Dr. Bhupinder Singh will find out that whether the UGC Persons with Disabilities Scheme in Universities XII Plan (2012-2017) is still going on or not and let to know to Committee within a week.
3. The Department of Education will start the Interdisciplinary Course (IDC) for Learning Disability.
4. Dr. Bhupinder told to committee about the equipment and services established in Library for Persons with Disabled like Scanner for Low vision, Head Phone for Hearing Impaired, Wheelchair, bell at 1st and IInd floor for


handicapped (if he/she wants to enter from 1st and IInd floor), staff nominated to assist to scan the documents etc. Accordingly, the committee ask to Dr. Bhupinder to provide the complete details about facilities.


5. Dr. Bika will find out the free software useful for Persons with Disabled and informed to Dr. Bhupinder about the free software.
6. Dr. Bika and Dr. Pradeep will meet with PWDs students and tell them about the Beneficiaries Schemes and guide to them about how to apply for the schemes.
7. The committee noticed that the Accessible Toilets established in the University is not as per the norms and suggested to inform to Estate Office/Engineering wing.


