# MEMORANDUM OF ACADEMIC SUPPORT

This Memorandum of Academic Support ("MoAS") is entered into on the 21<sup>st</sup> day of August, 2018.

BY AND BETWEEN

The **Central University of Punjab (CUPB), Bathinda** was established in 2009 by an Act of Parliament (No. 25 of 2009) having its transit campus at City Campus, Mansa Road, Bathinda-151001, here after referred to as CUPB. CUPB is a premier organization that offers a wide range of instructional and research facilities across integrated and cross-disciplinary studies to uplift and upgrade the standards of teaching, learning and research to global levels of excellence.

AND


The part of **Society for Promotion of Science and Technology in India (SPSTI) in Bathinda**, a not for profit NGO (reg no.80/2009 ) under the societies and registration act 1860.

'SPSTI' and 'CUPB' hereinafter also referred to as Institution or Institutions as per the context.

NOW, THEREFORE, SPSTI and CUPB agree as follows:

**1. OBJECTIVES OF MoAS**

Within the mandate, rules and resources available, the two institutions shall seek to promote and arrange events for:




1. Training of College/ School Science teachers.
2. Exposure of science students to various Lab Techniques and equipment.
3. Interactions with renowned scientists and educationalist through lectures, seminars, and conferences, workshops, & debates.
4. Apprising students about various scholarships, loans and other supports available from Govts, Corporates, NGOs, International organizations and individuals.
5. Cooperation in Projects and Research activities of mutual interest.
6. Promotion of science and technology with the help of DST (GOI) and other Govt departments and organization.

## 2. AMENDMENTS TO THE MoAS

No amendment or modification of this MoAS shall be valid unless the same is made in writing by both the Institutions by their authorized representatives and specifically stating the same to be an amendment of this agreement. The modifications/changes shall be effective from the date on which they are made/executed, unless otherwise agreed to.

## 3. DISPUTE RESOLUTION

Difference of opinion, if any, arising during the period of this agreement, concerning the execution of the responsibilities will be settled on the basis of mutual consultation by the signatories or their designated nominees. The Institutions will make best possible efforts to resolve the dispute and in case of their failure to do so and reconciling the dispute mutually, the same shall be referred to president society for promotion of science and technology in India and Vice-Chancellor, CUPB jointly. Their joint decision shall be final for both the Institutions.



4. OBLIGATION

There shall be no financial liability on SPSTI and CUPB during the period of MoAS. In the event of cessation of this agreement on its expiry or earlier with mutual agreement, both the Institutions shall be relieved of their obligations under this agreement except those provisions hereof that by their nature are intended to survive such terminations.



5. EFFECTIVE DATE

The MoAS shall remain in force for a period of 1 (ONE) year initially, commencing from the date of signing and may be reviewed by mutual consent by serving 1 (ONE) month written notice to the other institution. Upon renewal, both institutions shall select either to proceed with the existing or new terms of understanding.

Both SPSTI and CUPB reserve the right to terminate this MoAS by either institution giving 1 (ONE) month written notice to the other. Where such termination occurs, provisions of this MoAS shall continue to apply to ongoing activities until their completion.

6. EXECUTION OF MoAS


SPSTI and CUPB welcome establishment of this MoAS for cooperation and jointly agree to the provisions as set out above. There are two copies of this MoAS, equally valid and one for each institution, effective from the date of its signing.


