Parkash Singh Badal, who is always striving to promote education for women, especially in the remote rural areas of the state, established 'teacher education college' with its identification as Dasmesh Girls' College of Education – Badal in 2005




WHEREAS the First Party come to an understanding with the Second Party to help the second party in its academic pursuits. The First Party will allow the Second Party to use its Library and Research facilities and will also help the teacher of the Second Party in pedagogy and other academic matters.

#### TERMS AND CONDITIONS

1. The MOAS shall deemed to have been automatically rescinded after the expiry of the MOAS period, unless renewed for any further period as per mutually agreed upon terms at a later stage.
2. It is further agreed that following the termination of the MOAS , both the parties shall refrain from carrying out the balance of the activity agreed upon in this MOAS.
3. Either of the parties hitherto shall be entitled to terminate the MOAS at any time with valid reasons acceptable in writing to both parties and in such case, the MOAS will terminate six months after the date of written notification or date of expiry of the MOAS, whichever is earlier. In case of such premature termination of the MOAS, all rights and obligations of both parties shall automatically cease except for those covered by written contracts including ongoing collaborative activity that can no longer be cancelled.
4. This MOAS is being done as the University has adopted 5 villages and this village is located in one of these 5 villages i.e. Village Badal.
5. In case of any dispute that may crop up during execution of MOAS, the matter would be settled through arbitration by referring to a committee jointly appointed by both parties.




