

## Minutes of the Meeting of School Board

The meeting of School Board, School of Legal Studies and Governance was held on 10.6.2016.

In the beginning, the Chairperson welcomed the Members of the Faculty. It was appraised to the members that in pursuance of recommendation of the School Board in last meeting to sign MOU with prestigious NLUs- a Memorandum of Understanding has been signed with Rajiv Gandhi National University of Law, Patiala.

After the deliberations in the Board of Studies in the Centre for Law, School of Legal Studies and Governance, the syllabus of LL.M. and Ph.D. Courses have been presented in the School Board.

**These items were approved after the suggested amendments by the Members of the Board as shown.**

Agenda No. 1: Approval of Minutes of the Meeting of Board of Studies, Centre for Law.

Agenda No.2: To approve specializations in Family Law and Intellectual Property Law.

Agenda No. 3: To discuss the prospects of increase in number of seats and finalize the



modalities for offering specialization in LL.M. 2<sup>nd</sup> Year, minimum number of students offering specialization.

Agenda No. 4: To discuss the prospects of Five Year Integrated Course in Law with specialization B.Sc.,LL.B.(Hons.); B.Tech.,LL.B. (Hons.) in coming academic session 2017-18.

Agenda No. 5: Any other item with the permission of the Chair.

**Item No. SLSG/SB:2:2016:1**

Minutes of Board of Studies, Centre for Law were approved. The members of School Board expressed their reservations regarding the contents of the syllabus. It was suggested that contents of 2<sup>nd</sup> Unit should be restructured. International Law should be shifted to 2<sup>nd</sup> Unit and 4<sup>th</sup> Unit should contain only Administrative Law. The Unit should also cover a topic on 'nature and scope of administrative law.

Besides, Entry 7 under Unit III should be amended as Consumer Protection Act, 1986.

In Unit, IV on Administrative Law- a topic of judicial review should be added.

Accordingly, suggested readings should be modified. Entry on Labour Law and Industrial Law in suggested readings should be removed. In Course Code- EVL 602- Book of Dr. Gurdeep Singh Bahri should be added.

In suggested readings, 'New edition (2015) of Environmental Law' by Prof. P.S. Jaswal and Prof. Nishtha Jaswal should be added.

In Semester IV- Course code EVL- 2<sup>nd</sup> Unit should be restructured by specifying the titles of the Acts and rationalized with other Units. Entry no. 7 and no. should be 'Corporate Social Responsibility' should substitute the existing heading. Heading no. 8 should be erased as it is already covered under the Sectoral Laws.

Page no. 26- in suggested readings: Companies Act, 2013 should be added in place of the Act of 1956.

Page no. 26- title of Paper CPL 602- Title should be Competition Law and Unit 3 should contain Entry no. 6 & 7, further Unit 4 should contain the Entry No. 8 & 9. Therefore, existing Unit 4 should be removed.

Title of Paper CPL – 603 should be 'Regulation of Financial Market and Forest Investment' instead of present title. Unit-I should cover specifically instruments of Capital Market. In first Unit- I, financial system and capital market should be covered.



First topic should be 'Introduction of Financial System followed by Meaning of Capital Market.

Topic on FEMA under Unit- II should be shifted to Unit-III with Entry no. 4. It should also affect Unit- IV as there shall be no need for Entry no. 8 in this Unit. Topic on Modes of Foreign Investment in India under Unit-I should be shifted to Unit-III with topic on FEMA.

Special focus on Financial Market covering agencies and authorities in Financial Market should be devised and few parts of this paper can be reduced. New Company Act along with under the title 'Relevant Provisions of the Company Act, 2013' should be added.

Instead of Corporatization of Stock Exchange – Role and Powers of SEBI should be added.

In Course Code HRL 602: Entry no. 4 given under Unit II should be shifted to Unit I.

In course Code HRL 603: Entry no. Juvenile Justice ...Act, should be modified by adding the year of 2015.

The Contents of the courses on Family Law and IPR were approved. Offering of these courses shall depend on the Administration of the University.

It was suggested that mostly there should be minimum 5 students opting for a specialization. However, it depends upon the Departmental Body to decide minimum number of students.




Item No. SLSG/SB:2:2016:4

It was suggested that in principle, it can be started. It was also suggested that people from other centres to offer these courses. The participation of other concerned schools should be ensured.


It was resolved that the School Board is agreed in principle on introducing such innovative courses and therefore, there is a need to frame strategy in consultation with faculty from other Centres.






