**To approve the Syllabus of LL.M. 2 Years Programme recommended by BoS**

The School Board examined the syllabus minutely and considered the suggestions of Board of Studies in the contents. It approved the suggested amendments in the Course Structure and contents of few courses subject to following suggestion:

1. In Paper LSR 501, Research Methodology and Legal Writing- It was suggested to add some content on use and importance of Statistics in Research Methodology and Legal Writing.
2. In Paper LSR 551, Judicial Process, it was suggested to remove old judgments and suggested the new judgments.
3. In Paper LSR 552, Indian Constitution and New Challenges, reshuffling of contents was made in addition to insertion of topics namely, Cultural and Educational Rights of Minorities, Right to Constitutional Remedies, Safeguard to civil servants etc.
4. In Paper LSR 553, Comparative Law and Public Governance, it was suggested to add Rule of Law, Separation of Powers in Unit- I and Institution of Ombudsman in Unit- IV.
5. In Paper LSR 554, Principles of Legislation and Interpretation, it was suggested to specify the contents of principles of Constitutional Interpretation, components of Internal Aids to Construction and External Aids to Construction along with shifting of *Ejusdum Generis* & Harmonious Construction to Unit-I.
6. In Paper EVL 652, Role of Judiciary, NGOs in Environmental Protection – Right to Protection Against Noise Pollution was edited.
7. In Paper HRL 651, Human Rights of Vulnerable and Disadvantaged Group, Victim Compensation and Recent judgments on Criminal Justice System were added.

**Item No. SLSG/SB:3:2017:3**


The members considered the recommendations of BoS regarding list of Journals to be recommended to UGC and approved the list with addition of few more prestigious journals of Universities.




The meeting ended with a vote of thanks by CoC, Centre for Law to the Chair of School Board and all the members for their inputs.
