Dr. Mishra before taking of the agenda items informed that Prof. Parmjit Kaur & Prof. Karamjeet Singh expressed their inability to attend the meeting of the School Board because of their committed exigencies and requested for leave of absence which was granted. Thereafter, Dr. Mishra presented the agenda items. The committee discussed and deliberated on the following Agenda items:

1. Finalization of revised curriculum of M.Com. Programme.
2. Finalization of revised curriculum of Ph.D. course work in Commerce.
3. Recommendation for the recognition of Chartered Accountancy qualification for registration to Ph.D. Programme in Commerce.


The School Board Meeting resolved as under:


1. The learning outcomes of each course are to be reframed point wise covering all the units.
2. The course Advertising and Sales Management is to be moved to 3rd Semester, HRM to 1st Semester, and Corporate Governance and Business Ethics to 4th Semester.
3. The courses OB and Business Research Methods are to be interchanged.
4. In the course Managerial Accounting, Units 2nd and 3rd are to be interchanged with emphasis on smooth and logical flow of topics of study.
5. The latest developments in the field should be added to all the courses.


6. In the course Financial Services, crypto currency and block-chain should be added.
7. In the course Contemporary Issues in Accounting, block-chain accounting is to be added.
8. It is suggested to design a new course on Database Management System and should be placed as an elective course prior to the course Business Analytics from the Year 2020-21.
9. The seminars preferably be made theme based, viz., recent developments in international business, e-commerce, financial services and business environment.
10. In the course Project Planning and Control, the use of MS-Project should be added.
11. The Value Added course Academic Writing should be replaced by Data Analysis using MS-Excel.
12. All the courses of Ph.D. course work in Commerce should be revised by adding contemporary issues in the field.
13. Regarding the recognition of Chartered Accountancy qualification for admission/registration to Ph.D. Programme in Commerce in the Department of Financial Administration, the eligibility criteria as suggested by the Board of Studies in its 4th meeting held on 12 Feb 2019 is duly accepted and recommended for consideration in the Academic Council. The said eligibility criteria may be read as:


"A qualified Chartered Accountant having secured 60% marks in aggregate or equivalent, along with graduation in Commerce and with professional experience of Five Years".


