The BOS meeting resolved with the following suggestions:



3. The Board resolved with the suggestion that at least 3 students are required to offer a course at the Ph.D course work level.




4. The suggested revisions in the existing syllabus of Issues of Trade and Development have been duly incorporated (Ph.D in Economics).

11. It also resolved that all the Programmes and Courses discussed in the School Board meeting may be approved by Academic Council.




