To consider the recommendation of the Selection Committee for appointment of Professor of Practice in the University as per UGC Guidelines.	The University Grants Commission vide Public Notice dated 30.09.2022, notified the Guidelines for engagement of Professor of Practice in the Universities.  In this regard, The selection committee constituted for considering the application of Mr. Ninder Ghugianvi as Professor of Practice at Central University Punjab. The committee met on 05.09.2024 and the Following members were present in the meeting:

The committee reviewed the CV of Mr. Ghugianvi and considered



his extensive experience in the fields of Punjabi and Hindi literature, publications, theater, music and the film industry. His lifelong association with national and international print and electronic media, particularly Punjabi media, and his connections with NRI writers and influential figures were also acknowledged.

Given his experience in both the creative arts and media, the committee recognized Mr. Ghugianvi's potential to facilitate industry-academic collaborations. He can effectively connect academic institutions with industry professionals for workshops, guest lectures, and practical projects, thereby enriching the learning experience for students and providing the industry with fresh perspectives and emerging talent.

Mr. Ghugianvi's expertise is expected to be particularly beneficial to students and researchers in the departments of Punjabi, Hindi, Performing and Fine Arts, and Mass Communication and Media Studies with following details:

- 1. University Publication: Mr. Ghugianvi should write a comprehensive book on the Ghazal writer Ustad Deepak Jaitoi, covering the lesser-known aspects of his life, personality, writings, memoirs, and aesthetics. Ustad Deepak Jaitoi is a foundational and renowned Ghazal writer in Punjabi literature, yet his works have not been widely discussed in Punjabi academia.
- 2. Promote Punjabi language and Punjabi folk culture.
- 3. Enhance the perception of the university through radio broadcasting and by promoting community outreach activities.
- 4. Lectures and Interaction Meets: Deliver frequent lectures and host interaction sessions to encourage students to engage in innovative and entrepreneurial projects related to literature, theater/film, and media.
- 5. Industry-Academia Collaborations and Networking: Facilitate networking of students with industries such as publishing houses, newspapers, radio, TV, theater groups, and local literary figures.
- Funding and Sponsorships: To assist the university in securing funding through sponsorships from Punjabi NRIs for student support and organizing international and national conferences and seminars.

The Committee unanimously resolved that:

- 1. Mr. Ninder Ghugianvi be appointed as Professor of Practice for an initial period of one year, further extendable as per UGC guidelines.
- 2. Mr. Ghugianvi shall submit a monthly report of his contributions to the competent authority.
- 3. Mr. Ghugianvi can visit CU Punjab upto 10 days in a month with honorarium of Rs. 5,000/- per day. Honorarium may also be paid for the field trips conducted for research, subject

- to the maximum limit of 10 days per month and approval of the competent authority.
- 4. The arrangement w.r.t. stay and food in r/o Mr. Ghugianvi during his visit to CU-Punjab shall be provided by the university.
