- 2a. To review and recommend the course structure and curriculum for M. Pharm., Pharmaceutical Chemistry and M. Pharm., Pharmacognosy for the session 2022-2024.
- Resolution: Course structures and curriculum for M. Pharm., Pharmaceutical Chemistry (Annexure C) and M. Pharm., Pharmacognosy (Annexure D) were reviewed and recommended for the session 2022-2024.
- 2b. To discuss/recommend the change in the program nomenclature from M. Sc. Chemical Sciences (Medicinal Chemistry) to M. Sc. Chemistry (Medicinal Chemistry) for the session 2022-2024 and onwards and recommend its course structure and curriculum.
- Resolution: The board was of the opinion that M. Sc. Chemistry (Medicinal Chemistry) nomenclature would provide the equal opportunities to the students as that of M. Sc. Chemistry students for appearing in the competitive examinations, getting admissions in national level laboratories, etc. Therefore, Board recommended the change in the program nomenclature from M. Sc. Chemical Sciences (Medicinal Chemistry) to M. Sc. Chemistry (Medicinal Chemistry) for the session 2022-2024 and onwards. However, no changes were suggested with respect to its course structure and curriculum (Annexure E).
- 2c. To review and recommend the course structure and curriculum for Ph.D. (Pharmaceutical Sciences) and Ph. D. (Medicinal Chemistry) for the session 2022.
- **Resolution:** Course structures and curriculum for Ph. D. (Pharmaceutical Sciences; **Annexure F**) and Ph. D. (Medicinal Chemistry; **Annexure G**) were reviewed and recommended for the session 2022.
- 2d. To discuss industrial training/internship of 4<sup>th</sup> semester students as per guidelines of National Education Policy 2020.
- **Resolution:** The BOS opined that a student might be allowed to carry out one's thesis or dissertation work in the concerned industry with the mutual agreement between the supervisor and the industrial counterpart.
- 2e. To discuss/recommend equivalence of M. Sc. Chemical Sciences (Medicinal Chemistry) with M. Sc. Chemistry of ongoing and previous batches

Resolution: The board was made aware that students of M. Sc. Chemical Sciences (Medicinal Chemistry) students, while appearing for any entrance/competitive like GATE, SET, NET, etc. face difficulty because of the course/program nomenclature. Therefore, the board recommended providing equivalence of M. Sc. Chemical Sciences (Medicinal Chemistry) with M. Sc. Chemistry for ongoing and previous batches. In addition, the board recommended changing the program nomenclature from M. Sc. Chemical Sciences (Medicinal Chemistry) with M. Sc. Chemistry (Medicinal Chemistry).
