With respect to the mail received regarding the implementation of approved National Credit Framework (NCrF) guidelines during curriculum update, UGC guidelines should be followed for the Multiple Entry and Exit Scheme. We need your kind approval for the below-mentioned agenda.

Agenda :

Regarding the implementation of the Multiple Entry and Exit Scheme:

As per UGC 2021 guidelines, for postgraduate programs, there shall be one exit point for those who join the two-year master's program, that is, at the end of the first year of the master's program. Students who exit after the first year shall be awarded the Post-Graduate Diploma.

4.1. Propose skills-based and vocational courses (4 credits) relevant to your program, a basket of all such courses will be available to the students who opt to exit the program.

4.2. The skill-based courses can also be enlisted from MOOCs (to be approved by CDDC).

4.3. A mini-project, such as industrial training, can also be proposed (with proper evaluation).

Resolution:

Our Department of Pharmacology is approved by the Pharmacy Council of India (PCI) and guidelines laid by PCI are followed for the M. Pharmacology curriculum. Currently, PCI has not issued any guidelines regarding the multiple entry and exit schemes.

We will frame the guidelines regarding the same as soon as we receive any notification from PCI.

You are requested to approve the same at the earliest.

Agenda :

Regarding the implementation of the Multiple Entry and Exit Scheme:

As per UGC 2021 guidelines, for postgraduate programs, there shall be one exit point for those who join the two-year master's program, that is, at the end of the first year of the master's program. Students who exit after the first year shall be awarded the Post-Graduate Diploma.

- 4.1. Propose skills-based and vocational courses (4 credits) relevant to your program, a basket of all such courses will be available to the students who opt to exit the program.
- 4.2. The skill-based courses can also be enlisted from MOOCs (to be approved by CDDC).
- 4.3. A mini-project, such as industrial training, can also be proposed (with proper evaluation).

Resolution:

Our Department of Pharmacology is approved by the Pharmacy Council of India (PCI) and guidelines laid by PCI are followed for the M. Pharmacology curriculum.

Currently, PCI has not issued any guidelines regarding the multiple entry and exit schemes. We will frame the guidelines regarding the same as soon as we receive any notification from PCI.
