- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

Comprehensive Annual Maintenance Contract and Refilling

(a) One Time Service.

- (i) The Contract shall include a General Service of Reconditioning, Refilling, Certification and Monthly inspection of the Fire Extinguishers.
- (ii) The General Service includes removal of existing fire extinguishers from various locations of the CUPB and taking the same to the contractor's factory / workshop location under his own expenses for reconditioning, repainting (wherever required), refilling, replacement of defective spares (if required) and placing the Fire Extinguishers back to the same location in the CUPB Campus.
- (iii) The Fire Extinguishers are to be taken in 02 batches to ensure availability of sufficient oper ational Fire Extinguishers at the various buildings of the CUPB.
- (iv) All extinguishers shall be examined internally and externally by the contractor for any dam age / corrosion and suitable painting shall be done as per requirement before refilling.
- (v) All extinguishers shall be **REFILLED** as per IS 2190:2010 (as amended from time to time)
- (vi) Water Type Extinguishers shall be refilled with Potable Water.
- (vii) All Fire Extinguishers must be discharged / emptied before refilling.
- (viii) The reconditioned and refilled fire extinguishers shall be labelled with information such as Serial No. of the Cylinder, Date of Refilling, Next Due Date, Type of Material Refilled and Ca pacity of the Fire Extinguisher.

(b) Monthly Service (Once in every month from the date of refilling)

- (i) Maintenance of all the Fire Extinguishers installed at different locations in CUPB.
- (ii) Cleaning the exterior of the extinguisher.
- (iii) The Routine service includes repair or replacement of hose clips, hose nozzles, body repair cleaning of fire extinguishers, Checking & replacement of pressure gauges, squeeze, grip, Syphon tube, discharge nozzle, repair/ replacement of brass portion, repair/ replacement of valves/ lids, fixing/ positioning of fire extinguishers, refilling, repair/ replacement of grip h andle/ PVC base/ trolley (as required). The contractor has to attach a report on individual Fire Extinguisher and also submit a monthly Report , w.r.t. refilling Fire Extinguishers according to pressure gauge or indicator, by weighing weight etc., and any other work to maint ain the serviceability of the fire extinguishers accordingly, to the Designated Officer of the CUPB.

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

Additional Terms and Conditions

- (i) Bidder having **Factory / Workshop in the State of Punjab are eligible to apply** for this bi d. Proof of the same is required to be submitted.
- (ii) After refilling and prior to installation, 2 or 3 fire extinguisher at random will be picked up for t esting, if any of the fire extinguisher's performance is found unsatisfactory then the entire lot will be rejected and the contractor has to make them good.
- (iii) Contractor will visit the site as and when complaint raised by the Designated Officer of the CUP B other than their monthly maintenance visit(s). On his visit he shall submit service report about satisfactory working of all the fire extinguishers to the Designated Officer.
- (iv) The contractor has to carry out a monthly maintenance and submit detail service report as per CUPB format for all fire extinguishers mentioned above in the scope of work.
- (v) If any damage to any cylinder and allied accessories occurred due to improper maintenance or negligence in workmanship or during transport, the parts/spares/defective cylinder will be repl aced by the contractor immediately free of cost.
- (vi) The contractor must furnish the documentary evidence of the material used for Refilling of the ABC type fire extinguishers and CO₂ Gas used for Refilling CO₂ fire extinguishers.
- (vii) The contractor must submit a **REFILLING WARRANTY CERTIFICATE** for the refilled fire extin quishers.
- (viii) The cost of transportation shall be borne by the contractor.
- (ix) All fire extinguisher of the University are marked. The same fire extinguishers, as taken from the University, shall be returned back. No fire extinguisher shall be replaced with any other extinguisher of the same capacity.

5. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

6. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

7. Past Project Experience

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य</u> नियम और शर्ते, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
