1. Purchase Preference (Centre)

Procurement under this bid is reserved for purchase from Micro and Small Enterprises whose credentials are validated online through Udyog Aadhaar/URC for that product/service category. If the bidder wants to avail the reservation benefit, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service.

2. Past Project Experience

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. 4. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. **DOCUMENTARY EVIDENCE TO BE SUBMITTED.**

5. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

6. Buyer Added Bid Specific ATC

- (i) Similar work means **"Refilling / AMC / CMC of Portable Fire Extinguishers"**
- (ii) Bidder having **Factory / Workshop in the State of Punjab are eligible to apply** for this bid. Proof of the same is required to be submitted.
- (iii) After refilling and prior to installation, 2 or 3 fire extinguisher at random will be picked up for testing, if any of the fire extinguisher's performance is found unsatisfactory then the entire lot will be rejected and the contractor has to make them good.
- (iv) Contractor will visit the site as and when complaint raised by the Designated Officer of the CU PB other than their monthly maintenance visit(s). On his visit he shall submit service report about satisfactory working of all the fire extinguishers to the Designated Officer.
- (v) The contractor has to carry out a monthly maintenance and submit detailed service report for all fire extinguishers mentioned in the Scope of Work.
- (vi) If any damage to any cylinder and allied accessories occurred due to improper maintenance or negligence in workmanship or during transport, the parts/spares/defective cylinder will be replaced by the contractor immediately free of cost.
- (vii) The contractor must furnish the documentary evidence of the material used for Refilling of the ABC type fire extinguishers and CO₂ Gas used for Refilling CO₂ fire extinguishers.
- (viii) The contractor must submit a **REFILLING WARRANTY CERTIFICATE** for the refilled fire extinguishers.
- (ix) The cost of transportation shall be borne by the contractor.
- (x) All fire extinguisher of the University are marked. The same fire extinguishers, as taken from the University, shall be returned back. No fire extinguisher shall be replaced with any other extinguisher of the same capacity.

Payment Terms

- (i) The payment will be made to CMC Service provider on quarterly basis (if the services are satisfactory) on submission of bill by the service provider on completion of each quarter after making necessary deductions, if any.

- (iii) All extinguishers shall be examined internally and externally by the contractor for any damage / corrosion and suitable painting shall be done as per requirement before refilling.

(b) **Monthly Service (Once in every month from the date of refilling)**

- (i) Visual Inspection of pressure gauge to confirm sufficient stored pressure in the extinguisher indicating proper functioning.
- (ii) Refilling of fire extinguishers showing low pressure with appropriate type of gas.
- (iii) Cleaning the exterior of the extinguisher.
