Minutes of Special Meeting of the Executive Council

The Special Meeting of the Executive Council of Central University of Punjab, was held on 7th January 2022 at 04:30 p.m. through online mode.

Venue: Conference Room, Aryabhata Academic Block, 1st Floor, Adjacent VC's Office. The list of the members present during the meeting is annexed.

The Chairman of the Executive Council welcomed all the members present in the meeting, especially the external members namely Prof. T.V. Kattimani and Prof. Sushma Yadav for making it possible to attend this Special Meeting on short notice.

Prof. Annpurna Nautiyal could not attend the meeting due to internet connectivity issues.

After detailed discussions on the agenda item listed for this meeting, the unanimous resolutions of the Council are as follows:

Item:No:EC:SM:2022:1 To consider the appointment of faculty positions in the Department of Botany.	NOTE: The Central University of Punjab, Bathinda released the Advt. No. CUPB/21-22/005 (Special Recruitment Drive) and Advt. No. CUPB/21-22/006 dated 07.09.2021 for recruitment of various faculty positions in different Departments including the Department of Botany, on regular basis The last date of applying online for all posts (except Assistant Professor) was 21.10.2021. While the last date for Assistant Professor was extended till 02.11.2021 in view of the Amendment to UGC Regulations. All the online applications were screened by the duly approved Screening Committee including the external expert. The remarks of the Screening Committee for individual candidates were uploaded on the university website giving three to five days to the candidates for claiming their ineligibility/provisional eligibility with requisite documentary proof through recruitment portal. All the representations/objections of the candidates were put up to the Screening Committee. Accordingly, a list of finally eligible/provisionally eligible candidates was prepared as per shortlisting proforma given in the UGC Regulations, 2018. As per policy of the university, minimum 2 and maximum top 25 candidates (or upto the last candidate scoring equal to the 25 th eligible/provisionally eligible candidate) against each of the post(s) category wise were called for interview. <i>Further, while rectifying the scores of one candidates (Dr. Somanjana Khatua) after calling of the 26 candidates, two additional candidates were called for the post of Assistant Professor (UR).</i>
