# Minutes of 48th Meeting of the Executive Council

The 48<sup>th</sup> Meeting of the Executive Council of Central University of Punjab, was held on 26<sup>th</sup> February 2024 at 05:30 p.m. through online/physical mode.

Venue: Conference Room, Aryabhata Academic Block, 1<sup>st</sup> Floor, Adjacent VC's Office. The list of the members present during the meeting is annexed.

The Chairman extended the warm welcome to the members present in the meeting, especially the external members, namely Prof. Manoj Dixit, Prof. K.R.S. Sambasiva Rao and Prof. Vandana Mishra for making it possible to attend this meeting (through online mode).

Thereafter, the Chairman informed the Council that 9<sup>th</sup> Convocation of the University is scheduled for 19<sup>th</sup> March 2024 and also shared that Shri Ram Nath Kovind ji, Former Hon'ble President of India, will grace the occasion as the Chief Guest and deliver the Convocation Address in physical mode.

Further, it was also shared with the Council that in this Convocation, in addition to routine conferral of degrees, four distinguished personalities namely Shri Ajit Doval, National Security Adviser, Prof. Vijay Bhatkar, highly-acclaimed Indian Computer Scientist, Dr. Jaspinder Narula, acclaimed playback singer, and Dr. Harjit Singh Sabharwal, renowned social activist, will be conferred *Honoris Causa(s)*.
