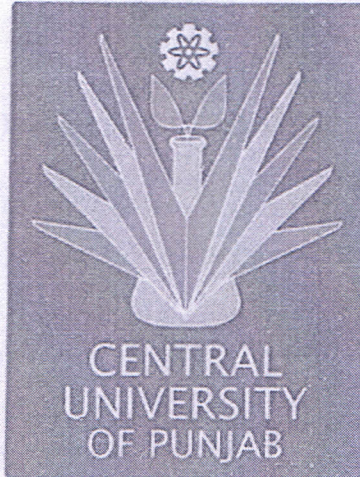

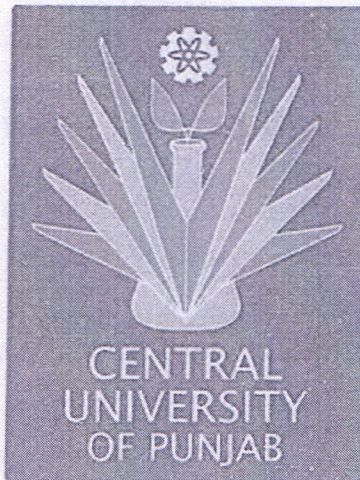

1. The **Central University of Punjab**, hereinafter referred to as "CUP" has been established through the Central Universities Act 2009 which received the assent of the President of India on 20th March 2009. Its territorial jurisdiction extends to the whole State of Punjab. This fast growing newly set up Central University is an important link in the recently set up chain of Central Universities created in the educationally backward areas throughout the country. This University is destined to emerge as a premier educational institution with the state of the art infrastructure to provide quality education and research in science and technology, humanities commerce, management and social sciences.
2. The **Baba Farid Group of Institutions (BFGI)**, located at Muktsar Road, Bathinda (Punjab), runs under the aegis of Baba Farid Vidyak Society, Bathinda founded in 1993, a Society registered under The Societies Registration Act (XXI of 1860) and as amended by Punjab Amendment Act, 1957 vide Registration No. 306/1994-95, a multi college campus which includes Baba Farid College, Baba Farid College of Engineering and Technology, Baba Farid College of Management and Technology and Baba Farid College of Education. This institution of malwa region (Punjab) having state of the art infrastructure, is committed for excellent education besides empowering its students to be more employable through its more concerned activities in Research for Science and Technology, Humanities, Commerce, Management and Social Sciences within an affordable range of students.

This MEMORANDUM OF Academic Support (MoAS) is entered into at Bathinda on this day ____ day of _____, 2020 by and between;



Central University of Punjab (CUP) being represented by its Registrar, having its office at Ghudda, Bathinda District, Punjab in India hereinafter referred to as the **PARTY OF THE FIRST PART**

AND

Baba Farid Group of Institutions (BFGI) being represented by its Deputy Director Academics, having its office at Bathinda, Punjab in India hereinafter referred to as the **PARTY OF THE SECOND PART**

WITNESSETH that;

WHEREAS, the Party of the First Part is an educational institution of national importance engaged in advancement of teaching and research in several branches of humanities, social sciences and science & technology, humanities, commerce and management. Reassuring its resolve and commitment and social responsibility towards the neighboring educational Institution needs of the area, adopted the Party of the second part to help its constituents for advancement of knowledge and creativity.

Whereas the Party of the 2nd part is an educational Institution shaping the career of its students besides bringing up to date its faculty through basic research and motivation.

WHEREAS both, Party of First Part and the Party of the Second Part with complimentary tasks have come to an understanding to promote cooperation between two organizations in the field of teaching and research.

NOW, THEREFORE, IT IS HEREBY MUTUALLY AGREED UPON BY AND BETWEEN THE PARTIES AS FOLLOWS:

1. This MoAS shall be valid for a period of two years to promote Innovation and Research which can be extended with mutual consent.
2. Both the parties will work together to enhance the faculty exchange program and will promote cooperation between both organizations in the field of Teaching, Research and Innovation in all the fields of Humanities, Commerce, Science (Physical, Life and Environmental), Management & Technology.



3. The faculty and research scholars of both parties will be available for helping each other to acquaint each other with the latest advancement in the above mentioned areas. The staff and students of both parties will have the liberty to use the facilities of Labs, library, playgrounds, Gymnasium, Auditorium etc. of each other, if available as per rules.
4. Both parties may allow the faculty of each other to attend all the research related activities such as seminars/conferences/workshops after paying the registration fee, if any.
5. Both parties may invite faculty & research scholars of each other to their Institution for interaction and for guidance as per the need and availability.
6. Both the parties will provide the technical support for seminars, conferences, workshops, Faculty Development Program and other academic meetings on the matters of mutual benefit as per the mutual agreements as and when required.

This MoAS may also serve purpose of Rastria Avishkar Abhiyan of MHRD through inspiring and motivating the young minds, teachers, and students for research and innovations.

TERMS AND CONDITIONS

1. The MoAS shall be automatically rescinded after the expiry of the MOAS period, unless renewed for any further period as per mutually agreed upon terms. It is further agreed that following the termination of the MoAS, both the parties shall refrain from carrying out the balance of the activities as agreed upon in this MoAS.
2. Either of the parties hitherto shall be entitled to terminate the MoAS at any time with valid reasons acceptable in writing to both parties and in such case, the MoAS can be terminated six months after the date of written notification or date of expiry of the MoAS, whichever is earlier. In case of such premature termination of the MoAS, all rights and obligations of both parties shall automatically cease except for those covered by written contracts including ongoing collaborative activities which cannot be cancelled.
3. In case of any dispute that may crop up during execution of MoAS, the matter would be settled through arbitration by referring to a committee jointly appointed by both parties.
