Consequent upon approval of the Competent Authority, it is hereby notified that 5-7 dissertations shall be assigned to each external expert for dissertation evaluation and viva-voce of Master's students. The HoD shall submit dissertations to the external experts through email prior to the date of Viva-voce.

The external experts may join the viva-voce, preferably in online mode. The Director, R&D shall nominate external experts for viva-voce from the list of external experts approved by AC/EC for the department.

The Dean In-charge Academics shall nominate external experts for viva-voce from the list of external experts approved by AC/EC for the department where the Director, R&D is a faculty member.

Departments, which do not have the list of external experts approved by AC/EC, the Hon'ble Vice Chancellor shall nominate the external experts for viva-voce and dissertation evaluation of Master's students.
